### Invitation to Bid

*Cab & Chassis for Dump Truck with 2 size options,  
with trade-in, with and without body, plow & wing*

### Bids Due June 8, 2017 at 3pm

The Town of Sharon is seeking bids on four options (Options 1A, 1B, 2A and 2B) for a new truck cab and chassis. Specifications below show Option #1A is for a six-wheel dump truck and Option 1B is for the same 6-wheel dump truck with a side dump body with plow and wing package. Option #2A is for a 10-wheel dump truck and Option 2B is for the same 10-wheel dump truck with a side dump body with plow and wing package. Bidders can choose to bid on any or all of the four options. Please fill out a separate bid form for Options 1A and 1B and another for Options 2A and 2B. In addition, we ask the bidder to provide the trade-in value for our 2010 Western Star 4900SA dump truck, which is kept at the Town Garage located at 6754 VT Rte 14 in Sharon; appointment with the Road Foreman required.

**Instructions to Bidders:** Companies interested in bidding must submit a bid(s) on the attached bid form(s), which must be filled out completely. If a change is made on the bid form, the contractor submitting the bid must initial and date the change.

**Bid Due Date:** Submissions are due at the Town Offices by **3:00 pm June 8, 2017**. Bidders may present their bid envelope marked **Cab & Chassis Bid** c/o Deb Jones, Finance Manager, at the Town of Sharon's offices via hand delivery at 69 VT Route 132, Sharon, VT 05065 Mon-Thurs 9am to 4:30pm (office and garage are closed on Fridays), or by mail to "Cab & Chassis Bid" Town of Sharon, PO Box 250, Sharon, VT 05065 (must be received by the Post Office by 8am the morning of June 8, 2017 to qualify), or submitted by email to [financemgr@sharonvt.net](mailto:financemgr@sharonvt.net) with the subject line reading **Cab & Chassis Bid** and the email must be timed and dated by June 8, 2017 at 3pm. No faxed bids accepted.

**Acceptance/Rejection of Bids:** The Selectboard reserves the right to reject any and all bids if it deems it is in the public interest to do so.

**Award of Bid:** An awarding of contract, if one is made, is expected to be made at a regular Selectboard meeting starting at 6:30 pm on June 19, 2017. However, bids must be valid for 30 days after bid opening.
