ADVERTISEMENT FOR BIDS
2020 PAVING PROJECTS

Bids for this project will be received by the TOWN OF SHARON SELECT BOARD **until Thursday, February 13, 2020 at 12:00 PM local time.** Bids will be opened at the Sharon Town Offices at 69 VT 132 in Sharon, VT on Thursday, February 13, 2020 at 12:00 PM local time.

Non-mandatory pre-bid meeting at Sharon Town Offices, Wednesday, January 22nd, 2020 at 1:00PM.

This project consists of paved highway rehabilitation for approximately 4.2 miles of paved roads in Sharon as outlined in the bid section of contract documents. Work includes a shim and overlay on River Road, reclaiming, adding fabric, and paving on Fay Brook Road, a shim and overlay on Broad Brook Road, a shim and overlay on Quimby Mountain Road, and reclaiming, adding fabric, dense graded gravel (as noted on plans) and paving on Howe Hill Road. Work also includes side road and driveway restoration, traffic control and signage, paved swales, intersection transitions, removing and replacing guardrails, shoulders, and curtain drains.

All work shall commence on June 1, 2020 or later. Final completion date for all work shall be August 15, 2020.

Liquidated Damages will be in the amount of \$750 for each calendar day of delay from the date established for Substantial Completion and \$750 for each calendar day of delay from the date established for Final Completion.

Bids will be received for a single prime Contract with the Town of Sharon. Bids shall be on a lump sum and unit price basis as indicated in the Bid Form. If additional work is requested, the unit bid prices shall be applied. Lump Sum price based on Engineers estimate will be used as basis for lowest bidder. Payment will be based on actual units verified by Engineer.

Pomfret and Sharon have similar bid packages for the Howe Hill Road portion of the projects, being advertised at the same time. Pomfret is rehabbing the south end of Howe Hill Road in Pomfret, for approximately 1.8 miles. Sharon is rehabbing the north portion of Howe Hill Road in Sharon, for approximately 2.7 miles (see separate bid package for Pomfret). **There will be separate contracts with each Town. The qualified bidder who provides the lowest combined bid for both Pomfret and Sharon projects will be selected.**

The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.
