#### **HOW WILL WE TRANSACT BUSINESS AT TOWN MEETING?**

Due to ongoing concerns regarding the spread of COVID, the Sharon Selectboard has taken formal action to move *ALL business* to be conducted at Town Meeting on March 1<sup>st</sup>, 2022 to Australian Ballot. Absentee ballots will be mailed to all registered voters in mid-February.

The polls will open for Town and School District in-person voting at 7:00AM, TUESDAY, MARCH 1<sup>st</sup>, 2022 in the Town Offices, 15 School Street. The polls will close at 7:00PM. All questions pertaining to town and school voting, voter registration, and balloting should be directed to Town Clerk, Catherine Sartor. Though you may vote in-person on Tuesday, March 1st, 2022 – the Selectboard strongly encourages voting by mail.

# HOW CAN WE DISCUSS THE BUDGET OR ARTICLES TO BE VOTED ON?

The Selectboard is required, by statute, to host a public information meeting to discuss Australian ballot articles on the town meeting warning with the voters. The articles to be discussed appear on the agenda enclosed with this notice and as published in the 2021 Sharon Town Report, and posted at the USPS in Sharon, Town Clerk's Office, and on the Town website <a href="https://sharonvt.net">https://sharonvt.net</a>.

The Selectboard will convene this virtual public information meeting at 6:00PM, TUESDAY, FEBRUARY 22, 2022. This is the only opportunity to *DISCUSS ballot articles* as a community.
