Call to Order:

Kevin Gish called the meeting to order at 4:15PM

1. Review/Approve Agenda

Mary Gavin made a motion to accept the agenda. Kevin Gish seconded. Motion approved unanimously.

2. Public Comments

3. Approve Warrants

Mary Gavin made a motion to approve AP Warrant 1515 in the amount of \$10,242.54 with payments to U.S.P.S \$528.00, US Treasury \$21.00, Valley News \$124.20, VLCT \$605.00, VMERS \$3,504.34, Windsor County Sheriffs \$5,460.00. Kevin Gish seconded. Motion approved unanimously.

Kevin Gish made a motion to approve AP Warrant 1516 in the amount of \$5,669 with payment to Reynolds and Son \$5,669.00. Mary Gavin seconded. Motion approved unanimously.

Mary Gavin made a motion to approve AP Warrant 1517 from the Old School House Fund in the amount of \$283.86 with payment to La Valley Building Supplies \$283.86. Kevin Gish seconded. Motion approved unanimously.

Kevin Gish made a motion to ratify payroll for the period 7/16/2023 – 7/29/2023 with a cash draw of \$15,632.67. Mary Gavin seconded. Motion rescinded for correction on Thursday 8/10/2023.

4. Set Tax Rate for FY24

Galen Mudgett joined the meeting at this point.

Galen said the biggest change he saw was reflected in the non-homestead education rate which he said is 13.6 cents higher than it was in 2022.*

Galen said it wouldn't hurt to bring this increase to the attention of the State Legislature since the education tax rate is out of municipal control. Galen said that while it is possible to assume that out-of-state property owners would be the group most affected by this education tax rate change, that assumption is not accurate. Galen noted that many in-state property owners, including those who have rental properties, for example, will also be affected by this increase in the tax rate which may ultimately have a negative effect on rental prices in the State.

Mary Gavin asked if the 13 cent and 15 cent increase is largely driven by the education tax increases.

Galen responded that, yes, on the non-homestead side, the increase is driven almost exclusively by the education tax increase. Galen highlighted that the municipal tax rate increase is only 3.20 cents in FY2024

Kevin Gish made a motion to set the FY24 Municipal Tax Rate to \$0.8170 and the Veteran's Offset to \$0.0024 as recommended by the Town Listers. Mary Gavin seconded. Motion approved unanimously.

*Rates for FY23 were set in 2022, so the increase refers to FY2023 rates as compared to FY2024 rates. Sharon Non-Homestead Education Property Tax Rates: FY2024 = \$1.781; FY2023 = 1.6556; FY2022 = 1.6981; FY2021 = \$1.59 Source: https://tax.vermont.gov/property/education-property-tax-rates
