State funds may not be available at the time this project is otherwise eligible to receive State school construction aid. The district is responsible for all costs incurred in connection with any borrowing done in anticipation of State school construction aid.

The Sharon School District School Board proposes to incur bonded indebtedness for the purpose of making capital additions and improvements to Sharon Elementary School at an estimated total project cost of Seven Million One Hundred Five Thousand and 00/100 Dollars (\$7,105,000.00). No portion (0%) of the project will be eligible for State school construction aid because State school construction aid is not available. Therefore, one hundred percent (100%) of the project shall be built at school district cost without State participation. The cost of the construction project which is to be paid by the school district is Seven Million One Hundred Five Thousand and 00/100 Dollars (\$7,105,000.00). So, Shall general obligation bonds or notes of the Sharon School District in an amount not to exceed Seven Million One Hundred Five Thousand and 00/100 Dollars (\$7,105,000.00), subject to reduction by federal or State grants-in-aid, be issued to fund capital additions and improvements to Sharon Elementary School including the aggregate estimated cost for which is \$7,105,000.00?
