Project Description: Winter Sand for the 2025/2026 winter season

The Town of Sharon is now soliciting bids for screened winter sand and a grittier sand product mixed with crushed stone. This bid price should include the cost per yard for both products.

Fixed price per yard for two products:

- 1. 2,800 yards of screened winter sand
- 2. 2,025 yards of a grittier sand product mixed with crushed stone 3/8 stone

We are planning on using a 50/50 ratio of these materials, within the quantity range you see for the two types of sand.

Please note, we may not choose to get both types of material from the same vendor. If you can only provide a quote for one of the two materials, please do so.

Also - please let us know where (which pit) and when this material would be available.

We plan to haul or have a contractor haul the screened sand material. We will be bidding that separately. Our road crew plans to haul the grittier sand material.
