  - Ag Census Records (1850-1880), also Manufacturing Census
  - Lots of book references
  - Title Chain: connect ownership through time, Beer's/Walling's Gazeteer, can go from Proprietor's Record" forward or go backwards. All surveys are recorded in Town records. We should have access to all survey records.
  - MS explained possibility of using Vital Communities funding for this project and also ed program with Meg Teachout.
  - UVM Consulting Archeology and Landscape Analysis groups may be useful.
  - Charlie thinks the scale of Ashley is manageable, and wants to help us!
  - Charlie is very interested in mentoring others to research.
  - "Those Who Stayed Behind" Chelsea, Civil War history
  - Check if surveyor has CAD or SHAPE file
  - Census records are in Hanover, NH and Montpelier
  - Next steps for ACF board: We gather some background info: Historic Societies, Conserv. Comms, Towns, interested individuals (Paul K., Steve Faccio, Tyler Robinson, Micki Colbeck?)
