#### 1. Public Comment Period

### 2. Approve previous meeting minutes

Dee made a motion to approve the minutes from the prior meeting with minor corrections to the dates (2025-01-27 18:00). Ryan seconded.

# 3. Shared Energy Coordinator updates

Ryan provided the following updates and information from the SEC group:

The Vermiculite remediation project at the Town Office that Henry helped initiate is currently ongoing and nearly complete.

Henry also performed a village sidewalk inventory for the Town to use toward future VTrans grant cycles and is well positioned to help with details in the Town Garage plan.

An in person meeting of the Steering Committee is planned for August at Lake Morey; Fairlee just joined the group.

Ongoing updates and adjustments to the E3 guide<sup>1</sup> have been ongoing as federal funding setbacks become clear. We discussed that one way to ensure folks in Sharon know about these funding sources still available is by actively sharing it through existing lines of communication such as the listserv.

We discussed having Harry look into the options for financing and power purchase agreements for putting solar PV on the roof at the Elementary School.

Ryan will finish measuring through August and Dee is going to help coordinate food for volunteers at the build. We may need some help with volunteers during the shift and for bringing food to feed the builders.

### 6. Continue Discussion Regarding Committee Direction, Name, and Scope

We discussed ideas for how to increase hyper local awareness of overly opportunistic ("invasive") plants, expectations around a future of sustained volatility, and indoor/outdoor air quality concerns.

Ryan noted that he achieved one of his personal goals of hosting a radio show on 96.5 FM (WFVR). The show is called Rutas Argentinas and is broadcast every other Friday at 10 AM.
